VANUATU - FACTS

Vanuatu is a **South Pacific Ocean** nation made up of **80 plus** island archipelago that stretch **1,300 kilometers**.

Multiple waves of colonizers, each speaking a distinct language, migrated to the New Hebrides in the millennia preceding European exploration in the **18th century**. This settlement pattern accounts for the complex linguistic diversity found on the archipelago to this day. The British and French, who settled the New Hebrides in the 19th century, agreed in 1906 to an Anglo-French Condominium, which administered the islands until independence in 1980, **when the new name of Vanuatu** was adopted.

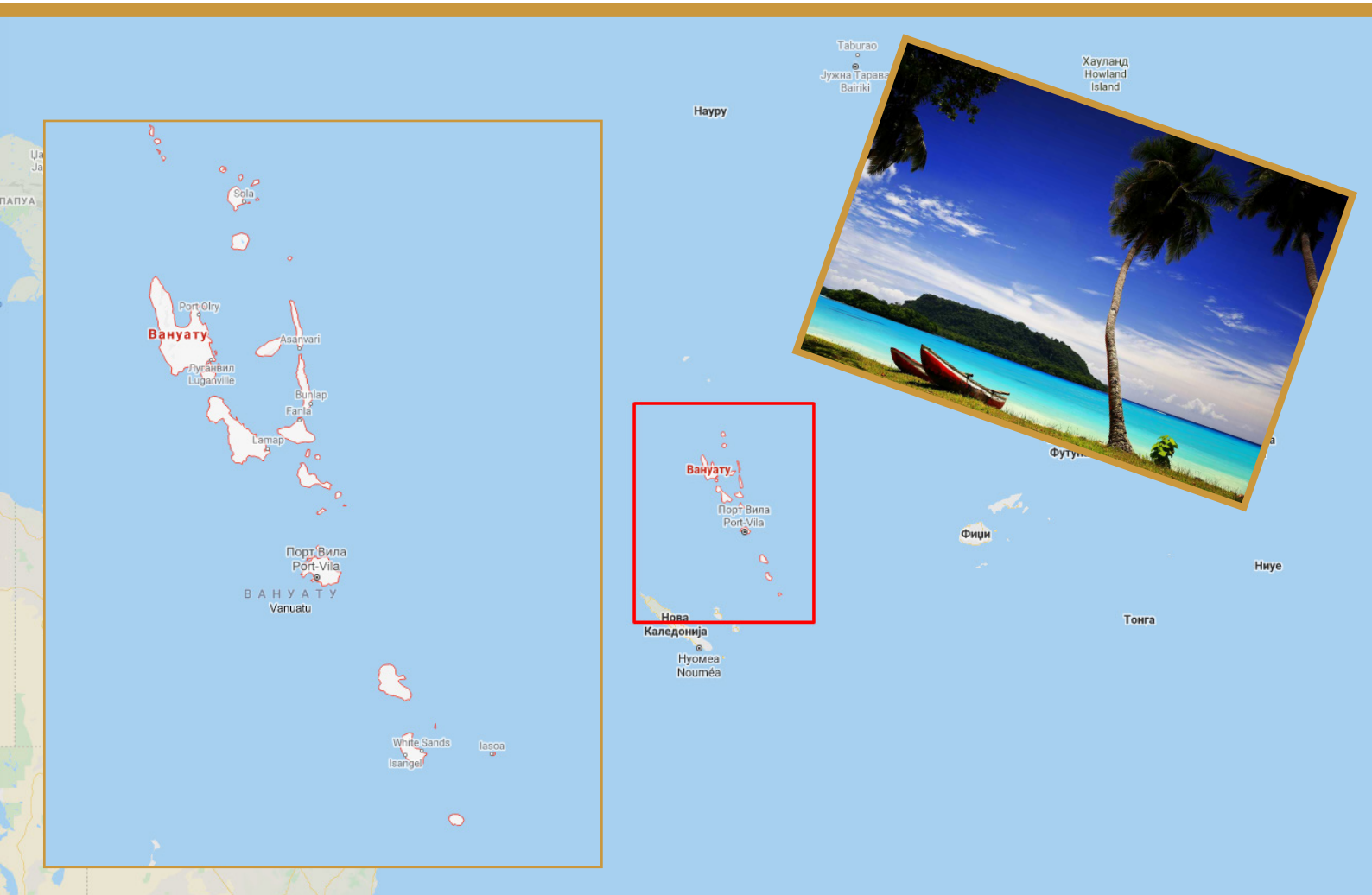
Religions: Protestant 70% (includes Presbyterian 27.9%, Anglican 15.1%, Seventh Day Adventist 12.5%, Assemblies of God 4.7%, Church of Christ 4.5%, Neil Thomas Ministry 3.1%, and Apostolic 2.2%), Roman Catholic 12.4%, customary beliefs 3.7% (including Jon Frum cargo cult), other 12.6%, none 1.1%, unspecified 0.2% (2009 est.).

Rich in culture, and in investments

Economy: primarily based on small-scale agriculture, which provides a living for about two-thirds of the population. Fishing, offshore financial services, and tourism, with an estimated 111,000 visitors in 2015, are other main stays of the economy. Australia and New Zealand are the main source of tourists and aid. A small light industry sector caters to the local market. Tax revenues come mainly from import duties.

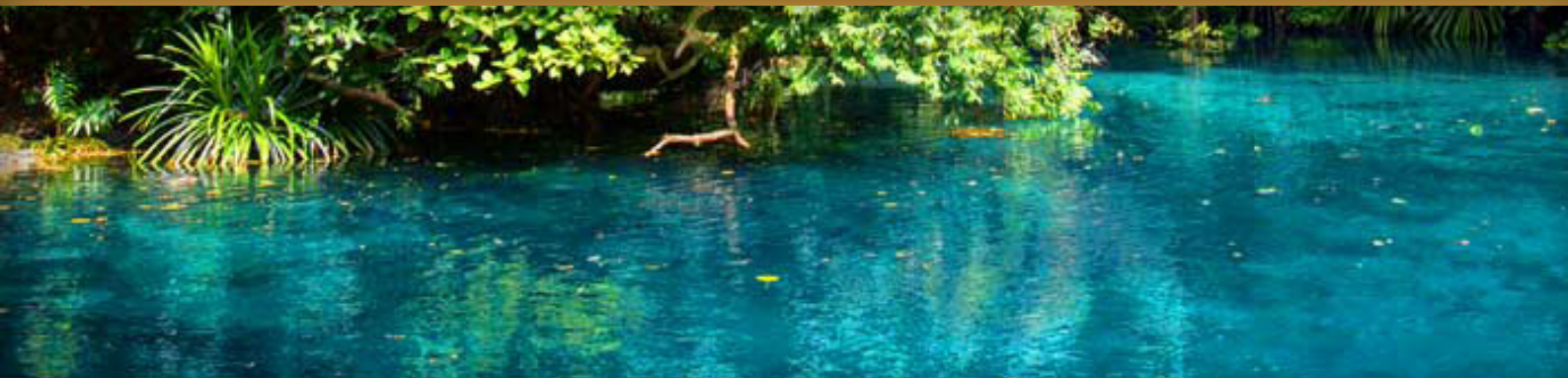
MAP OF VANUATU



VANUATU DSP OVERVIEW

In January 2017, the Government of the Republic of Vanuatu launched their Development Support Program (DSP) for the purpose of raising funds to support infrastructure and promoting economic development of Vanuatu. The DSP was enacted by the Vanuatu Government under the Citizenship Act (CAP 112) with the powers conferred on the Prime Minister by Section 20 of the Citizenship Act (112) Order No.215 of 2016. Pursuant to the Order, candidates may apply for Vanuatu Honorary Citizenship by contribution of USD 150,000 per application to the Government of Vanuatu.

VANUATU DSP OVERVIEW

On August 24, 2017, the Prime Minister of Vanuatu, in the official Gazette, published that he replaced the DSP. From this time, the Honorary Citizenship will be offered for US \$ 130,000 plus Government and due diligence fees. The citizenship acquired under the DSP program is fully recognized by the Government of Vanuatu and the nationality is regarded as Ni-Vanuatu. Those applying for and receiving Vanuatu Citizenship under the DSP have the full right to reside in Vanuatu at all times and the passport is renewable upon expiry.

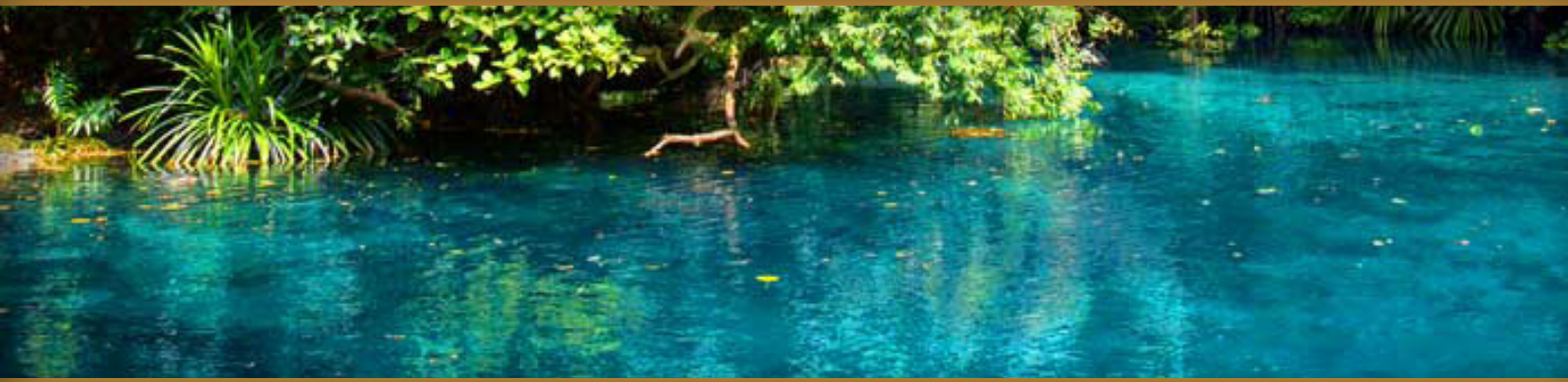

Vanuatu registered offshore companies and international companies are prohibited by law from undertaking business in Vanuatu either directly, or on behalf of residents of Vanuatu. In summary, Vanuatu is a pure tax haven for the simple fact that the offshore jurisdiction has no income or corporate taxes for both residents and foreigners.

Payment Steps:

STEP 1:

Background check Payment 10.000 US\$ for Family or 5000 US\$ for Single We need to report your data to the security authorities and decide whether you are allowed to submit the application. You pay only the background check. We need the passport copies from all applicants. The amount is not refundable. He will be deducted with the Advisor fee at the end.

Candidate has three options to take the **Oath of Allegiance** and picks up the passport:

- Travel to Vanuatu to appear before a commissioner of Oath to receive his citizenship certificate and Passport, Or
- Invite the Commissioner of Oath to his country to deliver the Citizenship Certificate and Passport. In this case, Candidate must pay for tickets and hotel. Or
- Wait for Commissioner of Oath scheduled visit to nearest Embassy or Vanuatu Diplomatic Mission (Brussels, New York or Beirut) to come in person and pickup his Citizenship Certificate and passport. May be also in the future in Serbian by the new Consul.

Documents for Government what we and our Lawyer needs

- Signing the Contract from the main applicant (YOU),
- Ensure that your personal asset statement is over USD250,000 – USD 350.000 and send a copy of Bank reference “Asset Report” (ie. Bank/ accountant) .
- International Medical check that each member are healthy and have no diseases Diabetes, HIV and TB or contagious diseases. (only the Original)
- Clean police record, from all members over 18 years age, from the country/countries that they reside in certificate by Notary and Apostille Stamp
- Passport copy from all members, certificate by Notary with Apostille
- Passport photo of white background (40mmx50mm)
- CV. personal Profile “Professional Reference” - if the client is self-employed, is a “Professional Reference” still required for the main reference? Resume- if self -employed, name of company, when it was set up, whether it was operation in which countries, whether it is making money
- Birth certificate from all members, certificate by Notary with Apostille (If no birth certificate has been issued, a statutory declaration should be made in front of notary public or relevant government authorities.)
- Married certificate certificate by Notary with Apostille
- Residency ID Card copy, from all members certificate by Notary with Apostille
- Power of Attorney from all members over 18 years age, certificate by Notary with Apostille Stamp
- All the documents have to be in English or have to be translated by the Certified Interpreter and notarized.
- And send the certificate Documents with Apostille to the Office with DHL.
